3. Only the reviewed papers will be published in the thematic proceedings. The papers that have not been completed according to the attached manual or not delivered to the specified deadline will not be printed in the thematic proceedings.

5. Deadline for submission of papers is 10 May 2026.

The fee for printing the paper is 30 euros per author, in dinar counter value on the day of payment. The amount of the fee is VAT included.

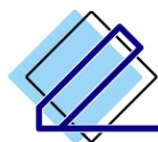
